**C.)** <u>DNA testing of Emu Oil</u> – Presented with another method of possible identification, FTIR. Andy will look into this further.

**Statement from Michael Sobel, New Jersey Laboratories, New Brunswick, NJ** - DNA testing might not be the best route for you to try and get your Emu oil tested. The test methodology that I mentioned over the phone is called FTIR and is a very commonly used technique in the pharmaceutical industry to identify raw materials used to make drug products. Please see below for a little background info on FTIR from the United States Pharmacopeia general chapter <197>:

"The IR absorption spectrum of a substance, compared with that obtained concomitantly for the corresponding USP Reference Standard, provides perhaps the most conclusive evidence of the identity of the substance that can be realized from any single test. The UV absorption spectrum, on the other hand, does not exhibit a high degree of specificity. Conformance with both IR absorption and UV absorption test specifications, as called for in a large proportion of compendial monographs, leaves little doubt, if any, regarding the identity of the specimen under examination."

What would be needed to perform this analysis is an Emu Oil sample and then the altered oil sample that you would like for us to compare it to. The normal turn around time is 12 business days and the typical cost for this analysis is in the ballpark of \$200. Please let me know if you have any questions!

Board agrees to continue looking at further ways of identification.

<u>Animal Waste Air Emissions</u> - U.S. Senate Committee on Agriculture, Nutrition, and Forestry Chairman Pat Roberts, R-Kan., today co-sponsored bipartisan legislation introduced by new Committee member Deb Fischer, R-Neb. The Fair Agricultural Reporting Method (FARM) Act would exempt air emissions from animal waste from being subject to the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) reporting requirements. Contact your US Senator to back this plan. Post to Facebook Network and Members YahooGroups list.

<u>Discussion Board</u> – YahooGroups has been giving us problems with board communication. It was suggested that the board consider using a Discussion Board instead and keep YahooGroups BOD email list as and archive for past communications and files. There is bbPress that integrates with WordPress on an existing website.

**bbPress.org** - bbPress lets you easily setup **discussion forums** inside your WordPress.org powered site. It is focused on ease of integration, ease of use, web standards, and speed. We will look into this further and other discussion boards.

International Certified Seal Use – If an International Member pays their annual dues, submits the program applications plus all program paperwork, is approved into the program and has liability insurance naming the AEA as an additional insured, they would be allowed to use the AEA certified seal/wording according to current regulations. Concerns were voiced that it is impossible to police the AEA Certified Seal use in foreign countries. This will be discussed further by the oil committee. <u>Online Emu Oil Prices</u> – Emu Oil (some AEA Certified) is showing up online at cut rate prices (less than half of what most are selling it for). Is this a response to the fake oil prices? Nothing we can do about pricing but, we must be aware.

**Eastern Equine Encephalitis (EEE)** - EEE was recently found in emus in Florida. Remind members to keep in contact with their local vet service to be informed, if an EEE outbreak occurs in their area and write an article for the newsletter.
