- CBM must provide a write-up about their company of 100 words or less.
- The company must provide proof of product liability insurance naming the American Emu Association as an additional insured
- The company must provide a credit or debit card for monthly fees to be charged to or prepay the fees upfront.

Special Promotion For 2020 CBM Fees:

- SAVE \$150 New members will be charged a reduced set-up fee of \$200 (normally \$350) that is due with the application.
- All members will be charged a monthly fee of \$50 that is due and payable on the 20th of each month. This monthly fee is to
 be automatically charged to the credit card on file unless the monthly fees are prepaid.
- Members may prepay the year in advance by check, credit card, or PayPal.


